For assignment travel-related allowances, travel lumpsum, Shipment (200 USD) and SIG as per the UNV Conditions of Service of 2015 as well as Pre-departure allowance (250 USD) will be provided for this assignment instead of Entry Lump Sum. Exit Allowance is not applicable and only travel lumpsum and Shipment (200 USD) for the repatriation will be provided for this assignment.

Living Conditions

Living conditions in Vientiane are relatively good and comfortable but residents must make concessions due to the tropical climate and underdeveloped infrastructure, especially health facilities. The UN Clinic provides health services for all staff and dependents but for some specialized treatments it is necessary to seek health care outside Laos.

Most commodities may be purchased in Vientiane. Vientiane is a relatively safe place to live in, with violent crime incidents very rare. However, single females should exert vigilance if moving alone during the dark and it is best advised to move in groups. Bag snatching and traffic accidents are number one hazards in the capital.

Whilst traveling in the Lao provinces, staff will experience more hardship due to lack of infrastructure and general commodities. There is a wide range of housing options in Vientiane located within easy reach of the UN House (where UNV offices are located). Houses or apartments are usually of good standards. All basic commodities can be bought in Vientiane and its immediate vicinity. House shares with 3-4 people are most common but single apartments are also available.

The Vientiane entertainment scene is still quiet and in order to avoid feeling lonely the person should be proactive in forming friendships, and hence should be ready to make the best of e.g. the UNV Buddy Programme. Vientiane's city centre is full of restaurants, shops, bars and internet cafes all line up along the Mekong river.

Laos has a relatively low number of Covid-19 case. Since 24 March 2020, there have been 45 confirmed cases reported in the country and 41 already recovered. The Lao Government has put in place a strict measure for Covid-19 prevention. This includes a suspension of tourist and visit visas, and commercial flights, and a closure of international borders.

He/She will also work in close collaboration with the United Nations Communications Group (UNCG) members based in Vientiane and the UNV Regional Office for the Asia Pacific (ROAP) based in Bangkok.

Under the direct supervision of the UNV Country Coordinator, the UN University Volunteer will undertake the following tasks:

- Support the promotion of volunteerism values in the country
 - Support the implementation of 2021 Communications Strategy including being a communications focal point for the Field Unit; regularly updating content in the social network pages of the Field Unit, and responding to corporate requirements;

work from their place of recruitment until restrictions are lifted. This is at the discretion of the host entity. Candidates proceeding to interview are recommended to discuss the likelihood of travel and possible alternative arrangements with the host entity. If selected, candidates should carefully consider the circumstances before accepting UNV's offer.

In cases where the UN Host Entity partner has requested the UN Volunteer to perform their assignment remotely, the Post Adjustment Multiplier (PAM) and related entitlements to be paid may be adjusted to the temporary duty station from where the UN Volunteer has been requested to work if requested by the UN Host Entity.

The contract lasts for the period indicated above with possibility of extensions subject to availability of funding, operational necessity and satisfactory performance. However, there is no expectation of renewal of the assignment.

A UN Volunteer receives a Volunteer Living Allowance (VLA) per month and is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of (choose from the drop down menu the appropriate rate here): US\$1,009 The VLA base rate is a global rate, while the PAM is country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website http://icsc.un.org.

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis.

Furthermore, UN Volunteers are provided a settling-in-grant (SIG) at the start of the assignment (if the UN Volunteer did not reside in the duty station for at least 6 months prior to taking up the assignment) and also in the event of a permanent reassignment to another duty station.

UNV provides life, health, permanent disability insurances as well as assignment travel, annual leave, full integration in the UN security framework (including residential security reimbursements). UN Volunteers are paid Daily Subsistence Allowance at the UN rate for official travels, flight tickets for the final repatriation travel (if applicable). UNV will provide, together with the offer of assignment, a copy of the Conditions of Service, including Code of conduct, to the successful candidate.

Supervision, induction and duty of care of UN Volunteers (Roles and Responsibilities of Host Entities)

UN Volunteers should be provided equal duty of care as extended to all host entity personnel. Host entity support to the UN Volunteer includes, but is not limited to:

- Introductory briefings about the organisation and office-related context including security, emergency procedures, good cultural practice and orientation to the local environment;
- Support with arrival administration including setting-up of bank accounts, residence permit applications and completion of other official processes as required by the host government or host entity;
- Structured guidance, mentoring and coaching by a supervisor including a clear workplan and performance appraisal;
- Access to office space, equipment, IT support and any other systems and tools required to complete the objectives of the assignment including a host entity email address;
